Presentation Categories

The 2016 Manitoba Planning Conference Program Committee is seeking presentations that are consistent with the conference theme. Presentation slots are one hour in length. Workshops of longer length may be available. Possible topics include, but are not limited to:

- ☐ Urban reserves, Treaty Land Entitlement, and municipal governments
- ☐ Indigenous Traditional Knowledge and land use planning
- ☐ First Nation and Métis engagement and consultation
- ☐ Community Engagement - IAP2 and beyond
- ☐ Public participation techniques - CommunityVis, open space, World Cafe, socratic circles, The Art of Hosting Conversations/Discussions
- ☐ New ways to tackle zoning bylaws (is zoning necessary? why do we zone?)
- ☐ Development cost / benefit analysis / pro-formas
- ☐ Subdivision design
- ☐ Cluster development in rural areas
- ☐ Downtown and main street revitalization
- ☐ Integrating land use and transportation planning
- ☐ Complete Streets and active transportation
- ☐ Community needs assessment
- ☐ How to review a site plan (adding value without undermining the designer and developer)
- ☐ Planning on the urban fringe
- ☐ Cooperation in Capital regions – Service sharing
- ☐ Immigration and settlement
- ☐ Planning for refugees involves more than housing
- ☐ Environmental planning and assessment, and climate change impacts on planning

Guidelines for Presenters

- All proposals are reviewed by a conference subcommittee.
- Presentations must be relevant to the theme of Envisioning Manitoba.
- Presentations should exemplify and articulate a specific activity or approach and have real-world application. Presenters must refrain from marketing particular products or services.
- Space for presentations is limited. Not all proposals submitted will be invited to present at the conference.
- Presenters do not receive remuneration.

Incomplete proposals that do not follow the guidelines will not be reviewed. One individual or group of presenters (limit of three presenters per group) may submit a maximum of two different presentations.

Notification of Results

You will be notified by **Friday, February 5, 2016** as to whether your presentation has been accepted.

Submission Checklist

- ☐ Please submit a detailed abstract of 200-400 words that describes the presentation content, and what the attendees will learn or take away from the presentation.
- ☐ Also submit a 75-100 word biography for each presenter and co-presenter(s) that details the presenters experience / qualifications to speak on the presentation topic.
- ☐ Please ensure that the submission includes the following:
 - ☐ Presentation title
 - ☐ Name(s) of presenters
 - ☐ Contact information of presenter(s)
 - ☐ Proposed length of presentation
 - ☐ Type of presentation (i.e. concurrent session and/or workshop)
 - ☐ Format of presentation (e.g. PowerPoint)
 - ☐ Special requirements other than basic Audio-Video (Computer, screen & sound system)
