Honourary Membership...

Honourary Membership is the highest and most distinguished honour that PIBC can bestow upon an individual who themselves is outside the planning profession, but who has made a significant contribution to planning or to the Institute. It is a rare and prestigious honour, which affords PIBC the opportunity to recognize such uniquely worthy individuals. The PIBC Board, at its sole discretion, approves the admission of any individual to Honourary Membership in accordance with the Institute's bylaws.

Seeking Member Input...

Each year the PIBC Board gives consideration to granting Honourary Membership to worthy, qualified individuals. The Board is also seeking input and suggestions from members at-large to ensure that qualified, worthy individuals are given consideration through a process that is as open and thorough as possible. Therefore, the Board is now calling for the submission of suggested, potential nominees for Honourary Membership from members.

Honourary Membership Eligibility Criteria...

In accordance with the Institute's bylaws (Bylaw 2.14.3), the PIBC Board may, by unanimous resolution and upon the nomination of at least two directors, admit an eligible individual to "Honourary Membership" in the Institute. The bylaws stipulate that it shall be someone who is:

- Not normally eligible for admission to corporate membership in the Institute (i.e. not a professional or practicing planner); and
- A person who warrants recognition for having demonstrated special interest in or concern for the planning profession, or who has given outstanding service or made a significant contribution to the Institute.

Honourary Membership is a rare and prestigious honour granted to individuals worthy of significant recognition. It is the highest honour that the Institute can bestow on an individual who is not a planner.

Making A Submission...

Members wishing to submit a suggested nominee for Honourary Membership should review, complete and submit the attached Submission Form.

Submissions should be made to PIBC, in confidence, no later than: **Friday, May 4, 2018.**
