Following graduation from the University of Waterloo School of Planning in 2008, he worked as a Planner 2 with the City of Kelowna for three years, where he worked on a wide variety of land use applications and policy projects including agri-tourist accommodation and ALR, coach houses, townhomes, apartment buildings, official community plan review, revitalization tax exemption areas, hillside development policy, various advisory committees, and other matters.

In 2011 he joined the District of West Vancouver as a Senior Community Planner. Here, Andrew worked for five years to complete a key waterfront development and municipal land sale in Ambleside, and major developments around Park Royal, Ambleside, Horseshoe Bay, and the Upper Lands (British Properties). In 2016 Andrew joined the Transit Oriented Development (TOD) and Master Planning team in the Vancouver office of IBI Group, an architecture, engineering and planning consultancy. Here over three years he worked across the continent with both public- and private-sector clients on TOD and transit-supportive projects, large-site master planning, and to bring the RailVolution TOD conference to Vancouver.

In 2019 Andrew moved to join the development team of a Canadian owner, operator, and developer of purpose-built rental housing, and is today working to bring several thousand rental homes forward in Metro Vancouver and the Capital Region.

Andrew has volunteered for years with the Urban Land Institute BC Young Leaders Group, first as an event volunteer and progressing to co-chair organizing the work of more than 25 volunteers.

His planning experience within municipal hall, as a TOD and master planning consultant, and as a purpose-built rental housing developer, is a unique blend that is ideally suited to the issues that we face today as a profession – namely, housing, and how best we can collaborate within our respective areas of expertise under the larger umbrella of our profession. Housing underlies virtually every challenge we face today, and we need a renewed focus on housing and transportation if the profession is to stay credible and relevant.

Lui Carvello, RPP, MCIP is passionate about the planning profession and hopes to continue his service to PIBC and its membership on the Board of Directors, including by bringing his legal perspective to the table. Lui considers law a speciality within his planning career, that first began with an interest in high school, then a BES (Honours Urban and Regional Planning) from Waterloo and an MES (Consensus Building and Dispute Resolution in Planning) from York while also going to Osgoode Hall Law School.

He has worked in planning departments in BC, Ontario and England, and with consultants, and now focuses on providing practical legal advice and creative options in planning, development and environmental matters. Carvello Law has 55+ local government clients across the province, along with work for a non-profit conservation organization, First Nations and the Province.

Lui has sought to contribute to the profession through volunteer efforts, speaking engagements, articles, sponsorships, and employment of young planning professionals.

Lui didn't expect to run for a sixth term, but events both within PIBC and from external sources have rejuvenated him and highlighted the value of his experience and strategic perspective. The Province's approach to professional regulation and the enactment of the Professional Governance Act may lead to provincial oversight, perhaps with a right-to-practice. Although Lui has never advocated for right-to-practice legislation, as this is an issue RPPs who practice planning on a daily basis should decide upon, he has strongly advocated for a fulsome analysis and discussion on the topic, and for PIBC to be ready should the Province bring planners under the PGA. He's also advocated for building a stronger relationship with the province and ministry staff, and had to fight for that again this past term when other agendas were sought to be advanced in a conflicting manner. (Like good planners, we found a win-win solution.)

With your support, Lui hopes to be able to continue on the PIBC Board and PIBC's Policy and Public Affairs Committee.
