On November 8th, 2021, the Parks Canada Agency announced the details of its vaccination requirement for all employees.

As per the Policy on COVID-19 Vaccination for Parks Canada Agency, employees must attest to their vaccination status. The requirement for employees to be fully vaccinated applies whether they are teleworking, working remotely or working on-site. This is a condition of employment and it applies to indeterminate, determinate (term), casual, as and when required, and student hiring (full-time, part-time and seasonal). Should you reach the point in the selection process where it is necessary to ensure terms and conditions of employment are met, the hiring manager or a human resources representative will contact you in order to complete a vaccination attestation form.

Based in the iconic townsite of Lake Louise, you will lead proponents through the development review process, fostering an understanding and appreciation for how management of development review is essential to long-term sustainability and success.

• Reviewing, analyzing and providing recommendations on development proposals and applications in the Lake Louise, Yoho and Kootenay Field Unit, as related to the relevant acts, regulations, policies, guidelines and safety codes.

• Working directly with proponents, onsite and virtually, on their proposal submission requirements and expectations.

• Working directly with proponents, onsite and virtually, to ensure compliance with the relevant acts, regulations, policies, guidelines and safety codes.

• Working directly with proponents, onsite and virtually, to help identify and address any issues or questions that may arise related to land use.
