## Responsibilities:

- Conduct detailed analysis of moderately complex rezoning and other development applications and provide professional opinions and recommendations to senior staff regarding these and other planning related matters
- Draft bylaws, amendments and consolidations, and provide interpretations to applicants and the public as required
- Prepare reports to Council in support of Community Development objectives and ensure recommendations are consistent with municipal policies, bylaws and specifications
- Liaise with various internal and external contacts on land development, design guidelines and general planning trends
- Answer enquiries and provide information to other departments and the public regarding planning, zoning, land use or related matters
- Contribute to the preparation and execution of public engagement events and related programs
- Provide guidance and assistance regarding the work of technical staff engaged in land development projects and direct the work of consultants involved in the projects

## Qualifications:

- University graduation in an appropriate discipline, plus a post-graduate degree in Community and Regional Planning, plus sound related experience in urban planning or an equivalent combination of training and experience
- Thorough knowledge of the principles, practices and objectives of urban planning
- Considerable knowledge of the policies, rules, regulations, bylaws, objectives and legislation governing community development
